SHIPPING & WARRANTY CONDITIONS & RETURN POLICY

SHIPPING:

Please ensure that you provide an accurate and correct delivery address. Please also make sure that the telephone number you provide is correct.

We are not responsible for unsuccessful deliveries or lost parcels due to an incorrect delivery address. If a parcel could not be delivered and is returned to us due to an incorrect delivery address, the buyer is entitled to a refund of the product price excluding shipping costs. If the buyer wants the order to be sent again to a different address, the shipping costs must be paid again!

If you leave a message for the delivery person to leave your package at the door or at any unsecure place, we cannot take responsibility for lost or not received packages! Please try to arrange delivery in person or ask the company to leave your parcel at a Packstation or shop nearby. If your parcel is shown as delivered but you have not received it, please contact the shipping company and file a complaint as soon as possible.

If your parcel arrives damaged, please refuse to accept it and ask the courier to write a complaint report. This will help us recover the value of the lost products from the delivery company and give you a refund.

WARRANTY CONDITIONS & RETURN POLICY

We ask that each disposable item be tested upon receipt of the package.

Some products are not durable consumer goods (the Elf Bar electronic cigarette), which means they have a limited lifespan. Warranty claims must be submitted by email. You can only report a defective product at the time and place of delivery, or in the case of delivery by courier, you can send us the claim within 48 hours of receiving the goods. Disposable items are single-use products, these cannot be repaired or checked for use. Therefore, we can only offer an operational warranty for these products 48 hours after accepting the package. In this case, the guarantee can only be claimed in the manner mentioned above. In case of a claim, the customer can send the faulty product back to us, and after we receive it, an inspection will be performed. If the product is faulty, we will send you a new one free of charge, provided it is in stock. The amount of puffs given in the product description is a rough estimate. The suction intensity may vary from person to person. According to the product description, one puff corresponds to 0.3-0.45 seconds of suction. Therefore, we do not accept any complaints regarding the product's capacity. The battery consumes more energy during use when the temperature is below 15 degrees Celsius and should, therefore, be considered as a factor affecting the product's capacity. If the lower LED flashes, this is a clear sign that the battery is naturally empty. For this reason, we do not accept complaints regarding the LED flashing. The defective electronic cigarette will be replaced depending on stock. The purchase price can be used as a voucher if the electronic cigarette is not in stock. The return shipment costs are at the customer's expense and can always be made by post in the original packaging. Loss of the package is the responsibility of the sender. The claim will be issued within 15 (fifteen) working days after filing the claim and returning the product. The above rights can only be exercised in the event of a failed delivery, not in the event of a fault caused by the consumer!

The warranty described above applies only to the product and does not cover damage caused by the product or other items. The defective electronic cigarette will be replaced as soon as possible. If the product is not in stock, the purchase price can be used as a voucher in our shop.

If you wish to return your order or some products, you have 14 days to do so. The buyer must bear the cost of the return. For hygienic reasons, we can only take back unopened Elf Bar products.

AGE VERIFICATION POLICY FOR PRODUCT DELIVERY

The delivery company may request documentation both during the delivery process and in advance to ensure that you are of legal age and entitled to purchase our products. It's an essential procedure aimed at verifying that our goods are sold responsibly and in compliance with age-restriction laws.

SECTION 20/A - Warranty conditions & Return Policy on products under the on-sale category.

In the "On Sale" category, it may happen that the expiration date of the products has already passed. Disposable electronic cigarettes are not food items but electronic products, so the expiration date solely indicates the manufacturer's warranty period for the battery included in the product. In the case of rechargeable products, this may mean that the usable time between two charges can decrease by 5-10%. This phenomenon occurs only in 10% of products belonging to the ON-SALE category. For products in the

On Sale category, we do not accept complaints based on warranty expiration dates.

The above-described warranty applies only to the given product and it does not cover any damage caused by the product, or other objects. The defective electronic cigarette will be replaced as soon as possible. If the product is not in stock, the purchase price can be used as a voucher in our store.
